

celebratory announcement graced the 76th and Ashland corridor, as Chicago Mayor Richard M. Daley and Alderman Latasha Thomas (D-17) joined Walmart associates and several other civic and community stakeholders to publicly announce the opening of several Walmart stores opening as early as the Fall

of 2011 and as late as the Spring of 2013.

It is expected that these new stores will create approximately 1,000 new jobs and about 200 construction jobs as part of a community agreement between Walmart and the City of Chicago.

This agreement, called the "Chicago Community Investment Partnership," is a five year plan dedicated to opening several Walmart stores, creating approximately 10,000 jobs and 2,000 unionized construction jobs, and is expected to generate more than \$500 million in sales and property taxes.

This agreement will also develop charitable partnerships worth an estimated \$20 million.

# **Senator Collins Honored for Commitment to Financial Issues**

pringfield, IL—March 9, 2011—In light of the centennial of International Women's Day, Illinois Treasurer Dan Rutherford is giving Senator Jacqueline Collins (D-Chicago) a lifetime achievement award for her tenacity in pursing and promoting financial fairness, literacy, education and awareness.

"It is with great honor that I present my good friend and former Senate colleague Jacqui Collins with this special award," Rutherford said. From fighting for people facing home foreclosures, to demanding expanded consumer education in the schools, to initiating a restriction on state pension fund investment in companies based in the Sudan, Collins has spent a lifetime dedicated to improving the human conditions of women—and truly all people—in Illinois."

Collins list of accomplishments is long. She pushed for payday reform, an extension of the statue of limitations for civil and criminal prosecution of sex crimes against children, a law to fight human trafficking of women, and legislation preventing
